Sister Keys: Newest CLT Preserve

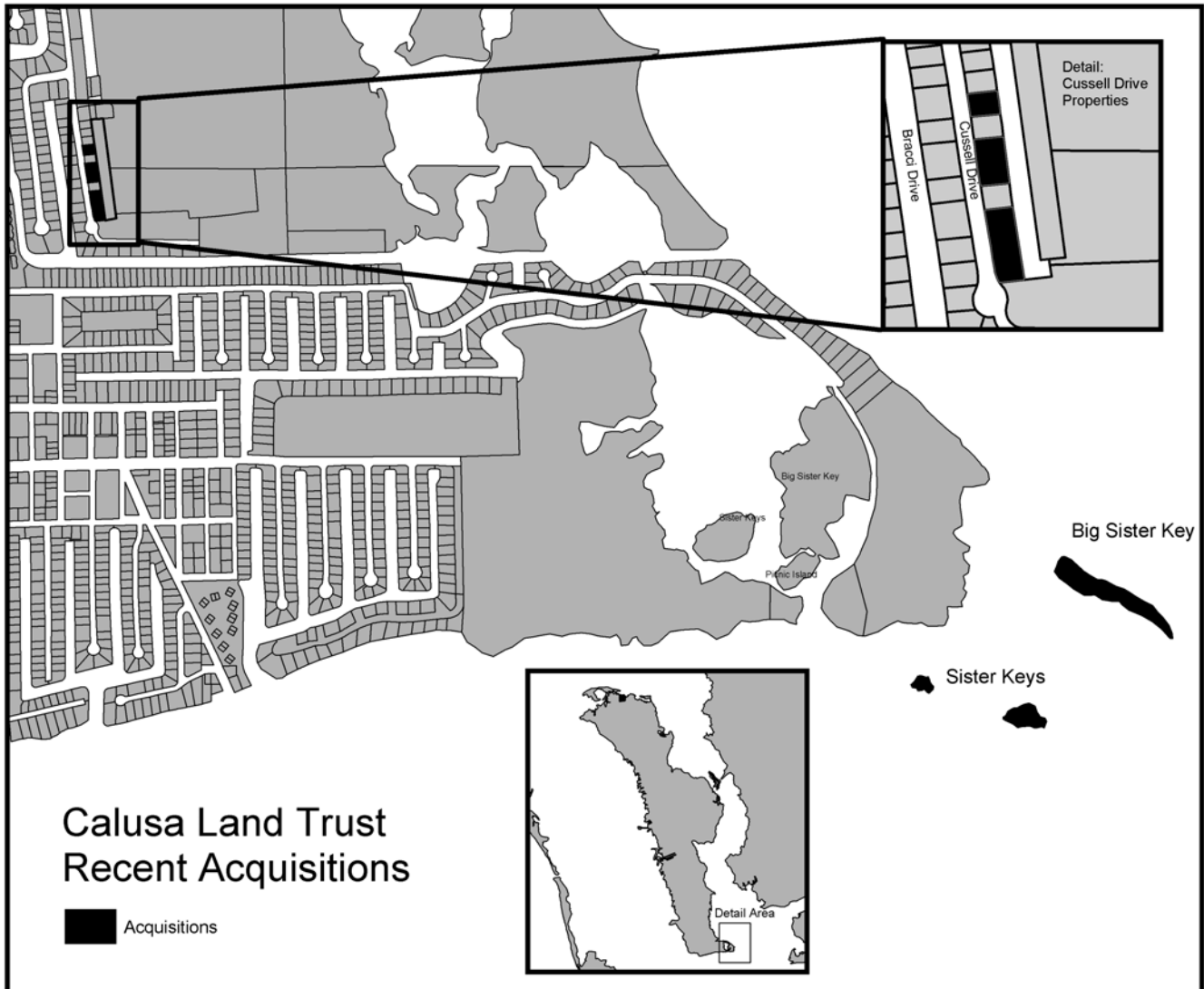
I am happy to announce that Calusa Land Trust has just acquired the Sister Keys, a group of three mangrove islands located off St. James City between Picnic Island and the southeast corner of Pine Island. They are about 7½ acres in all, with the largest island, Big Sister Key, being about six acres.

All three islands were owned by Charles E. McKenzie, a former resident, builder, and developer who lived on Pine Island for many years. You may remember that in 1996, he sold us over 180 acres that became our Back Bay Preserve. Several weeks ago, we contacted him about the islands and after some brief negotiations, he agreed to sell them to us at the bargain price of \$15,000. We are very excited to add these beautiful islands to our other holdings in the immediate area (see map on the next page).

After exploring the islands on two occasions, I was unable to find any high ground on the larger mangrove island, but when venturing onto the smaller islands was surprised to find several different plant species other than red mangroves. With the help of board members Brian Cotterill and Judy Ott, we identified black and white mangroves, buttonwood, strangler fig, seagrape, among several other natives. Three common exotic trees were also found — Australian pine, Brazilian pepper, and schefflera. Our volunteer rangers will be working very soon to remove these to give the native vegetation a chance to thrive in those areas once again.

Surrounding the keys are diverse habitats including sea grass flats, mangrove fringes, an oyster bar, and a long sandbar that together support a rich marine population. The birds are especially appreciative. A pair of opeys is nesting right now on one of the smaller islands, with numerous fish skeletons scattered below their eating perch. Bald eagles and frigate birds can be seen soaring overhead in search of a tasty meal. If you are lucky, you might also spot a dolphin or even a manatee. All three keys are within the year-round slow speed zone for the protection of manatees and tour boats visit daily to search them out.

While the islands will give us another beautiful preserve to explore and enjoy, it is clear that they also reflect the dynamic nature of a fragile island ecosystem. Tides and storms have naturally shifted their boundaries over time, but the huge waves caused by boats in the Intercostal Waterway are probably responsible for the erosion which can be seen on the two smaller islands.



Calusa Canal, Phase III Completed!

As previously reported, the Calusa Canal-Phase III has been in progress since June of 2002, when the Archeological Conservancy purchased a canal parcel located at 6360 Meadow Lane. Through a contract with that organization, Calusa Land Trust agreed to raise the funds to purchase this parcel and add it to the two nearby segments of the ancient Calusa Canal that we have already preserved.

The special fund-raising campaign came down to the wire but we are happy to announce that it was successful and the Calusa Land Trust now owns this third parcel. Like the other two, it faces Meadow Lane, which is the second street to the right off of Harbor Drive, after traveling north on Stringfellow Road.

St. James Creek Preserve Expanded

Adding new preserves is always exciting, but smaller acquisitions can be very important too. St. Jude Harbors is a subdivision in the southeast corner of St. James City. In 1992, the Calusa Land Trust purchased a large block of mangrove wetlands and high marsh just east of this subdivision. As you probably know, this large block of more than 300 acres is the heart of our St. James Creek Preserve, which includes the St. Jude Nature Trail heading east off of Stabile Road through the preserve all the way to the open waters of St. James Creek.

Just south of the Nature Trail is Cussell Drive. This is the street between the subdivision canal homes and the wetlands preserve (see map on page 2). A single row of residential lots on the east side of Cussell separates the street from the wetlands. Since the elevation falls quickly from the street to the marsh, Lee County has designated these lots as unbuildable.

An opportunity arose for the Calusa Land Trust to buy six of the lots near the south end of Cussell Drive. The seller was Beatrice O'Shea of Massachusetts. Ms. O'Shea is the daughter of Elmo Bracci, now deceased, who was one of the original investors in St. Jude Harbors. Bracci Drive, one of the streets in the subdivision, was in fact named after Mr. Bracci. Realizing that these lots were not buildable, Ms. O'Shea sold them to the Land Trust at a very favorable price, \$1,000 for all six lots.

Although small in size, we are quite excited about this purchase. Since the lots slope quickly from Cussell Drive to the wetlands, this narrow strip of land is prime habitat for Australian pine trees, which are not only hard to contain but are also blocking the view of the marsh and wetlands. In the coming year we hope to remove these exotics and create a beautiful vista of the preserve along nearly 500 feet of Cussell Drive. This small acquisition will allow residents and visitors a better opportunity to view and appreciate a significantly larger tract of pristine marsh and wetlands.

President's Report

At its first monthly meeting after January's annual membership meeting, the Board of Directors re-elected these board members to continue serving as officers for the coming year: President, Phil Buchanan; Vice-President, James "Alex" Alexander; Secretary, Rubye Woodhead; Treasurer, Bill Spikowski. Since that meeting Phil Buchanan has decided to resign his position and I have been elected to step in and serve as president for the remainder of this year.

As president and a board member, Phil did so much for the Land Trust that it is difficult to know where to begin in recognizing his accomplishments. Phil was the primary author of the popular *Nature Lover's Guide to Pine Island*, which was republished several times and is now in wide circulation. Following up on the land acquisition recommendations in the *Guide*, Phil served as the chairman of the CLT land acquisition committee, tracking land parcels the length of Pine Island, and negotiating to buy many significant properties. He has given knowledgeable talks promoting natural preservation to many groups. Perhaps most noteworthy has been his involvement in Lee County's Conservation 20/20 program, which largely through Phil's efforts has acquired a previously unimaginable amount of native habitat on Pine Island.

In 2001, Phil was recognized by his peers in the Florida Land Trust Network, which designated him their statewide "Outstanding Land Trust Volunteer" for the year 2001.

I am sure everyone involved with the Calusa Land Trust joins me in thanking Phil for all his tireless and productive work over the last several years on behalf of environmental preservation on Pine Island!

Ranger/Stewardship Report

On April 7, the Ranger Council met at Fritts Park and put together the work schedule for the rest of 2003. In addition to the monthly Saturday work parties, we will continue to meet for Sunday brunch work parties from 11:00 AM until 1:00 PM at Fritts Park (weather permitting). Look in the table below for all the specifics.

In April, our volunteers worked on the Long Cut and York/Coconut Island Preserves and in May we visited Calusa Island and the Calusa Canal where we removed exotic plants and trash. By the time this newsletter gets out we will have also worked at the St. James Creek Preserve and the St. Jude Trail.

Spring is our time for leading students on field trips, so on April 24 and 25, CLT Rangers took the Pine Island 5th graders to the St. Jude Trail, the Baxley Preserve, and also to the Randell Research Center. We had forty students each day along with some parents and we all had a great time. The students not only learned a lot about Pine Island's beautiful native habitats but also something about the importance of preserving it for future generations. I want to thank our Rangers who helped make it all possible: Bud and Shirley House, Bob and Jackie Kish, Bill Lester, and Bill Mantis.

On May 15, I spoke to the Pine Island Garden Club about the native plants and animals of Pine Island. There was a very good turn out and they asked many questions. In support of our efforts to preserve Pine Island, the club voted to make a \$500 donation to the Calusa Land Trust. We plan to put a memorial bench at Fritts Park in the near future for the Pine Island Garden Club.

We are desperately looking for more site leaders to help us oversee our ever-increasing number of preserves. The Trust has almost twenty in all and it would be nice to have someone in charge of each one. The main responsibility is to visit each site on a regular basis and monitor what the most pressing needs might be like trail building, invasive plant control, or trash clean-up. A site leader can also do plant and animal inventories and make other recommendations that would enhance the preserve. Two or three friends might want to share this job and take turns or work together. Please give me a call if you can help.

My last piece of news is very exciting. We have volunteered to help with a new juvenile fish study being conducted by MOTE Marine at Pineland. On May 10, nine CLT volunteers met with Dr. Aaron Adams who taught us how to catch and count juvenile fish. The data we collect will supplement ongoing research about juvenile fish populations around Pine Island. We hope to get started in June and will be looking first at snook until October when we will switch our studies to the red drum. We need about four more volunteers to make this more manageable for everyone. Let me know if you would like to help.
